## Who may compete:

Open to anyone who meets the eligibility requirements specified under NRA and CMP rules. Competitor must be a resident of Michigan and a member of the Michigan Rifle and Pistol Association in order to be the State Service Pistol Champion. MRPA requires that adult non-members be charged a \$5 fee for the event and that the sponsors remit said fees to the MRPA Secretary/Treasurer. Membership forms available at the range.

### Range Location:

The Joseph Beesley Pistol Range is behind the Taylor Hills Compost Center at 16300 Racho Road. From I-75 take the Eureka Road exit and go west ½ mile to Racho Road, then south ½ mile on Racho to Compost Center. From Telegraph Road, turn east on Eureka. Go 1 mile to Racho and then south ½ mile.

### **Entries Limited to:**

50 competitors. One relay. "Shoot the Works" entries given preference.

#### Facilities:

50 paved firing points. Loudspeaker system. Electronically controlled targets. Restrooms available. Covered eating area.

### Time:

Registration starts at 9am. The Service Pistol Championship starts at 10am. The CMP Service Pistol EIC Match and the NRA Distinguished Revolver Match relays will follow the Championship after a short break. The CMP 22 Rimfire Pistol EIC Match will be fired after all other firing is completed.

Categories/Classes: (Service Pistol C'ship only)

Competitors will be divided into two categories: Civilian and Service. Service will include Regular, Reserve, National Guard and Police. With fewer than five competitors in a category, the categories will be combined within the same class. With fewer than five competitors within a combined class, the competitors will be moved to the next higher class (except Master to High Master). Each match will have a Match Winner. In each class and category with 5-10 competitors, excluding Match Winner, there will be a first in class/category winner. With 11-20 competitors, a second in class/category will be awarded. Match Winners will not be eligible for any class award in the same match. A competitor will not be eligible for more than one award per match. In the event of fewer than five Master or High Master competitors, only match winner will be paid. Classes may be combined.

#### Awards:

<u>Service Pistol C'ship.</u> Awards for all matches will be cash, based on the NRA point system. \$1 per point will be mailed. The highest scoring competitor in Match 5 who is a Michigan resident and a member of MRPA will be declared the Michigan Service Pistol Champion and will be given possession of the Service Pistol Champion Trophy until the next Michigan State Service Pistol Championship.

<u>CMP EIC Matches</u>. Credit toward distinguished and/or Excellence-in-Competition" Badges in accordance with CMP rules.

NRA Distinguished Revolver. Credit toward Distinguished Revolver certification according to NRA rules.

Match 1: 20 Shots Slow fire @ 50 yds. (B6)

Match 2 (NMC): 10Shots Slow fire @ 50 yds.(B6)

10 Shots Timed fire @ 25 yds. (B8)

10 Shots Rapid fire @ 25 yds. (B8)

Match 3: 20 Shots Timed fire @ 25 yds. (B8)

Match 4: 20 Shots Rapid Fire @ 25 yds. (B8)

Match 5: Aggregate of Matches 1-4.

First stage: 10 Shots Slow fire @ 50 yds. (B6)

Second stage: 10 Shots Timed fire @ 25 yds. (B8)

Third stage: 10 Shots Rapid fire @ 25 yds. (B8).
