MATCHES: NRA 2700, NRA TEAMS, NRA DISTINGUISHED REVOLVER, CMP 22 RIMFIRE EIC, CMP SERVICE PISTOL EIC, NRA State Team Outdoor Pistol Postal and <u>.22 CALIBER ONLY AGGREGATE MATCH (Per NRA rule 22).</u>

ELIGIBILITY: Open to any individual who demonstrates safe range procedures. MRPA membership not required to compete. Adult non-members will be charged a \$5 fee. MRPA memberships will be available at the range. In order to be designated "State Champion" competitors must be a Michigan resident and a member of MRPA. CMP competitors are required to have an "Eligibility Affidavit and Liability Agreement" on file with WMRPC. CMP paperwork available at range.

RANGE LOCATION: WMRPC is on Lincoln Road, 1&1/2 mile west of Ionia. Take Exit 67 off I 96, go north on M 66 to M 21 (about 7 miles). Turn left (west) on M 21 and go about a mile to Lincoln Rd. Lincoln goes to the right as M 21 starts to curve to the south. Go west on Lincoln about 1.2 miles to the range (on the right). From the north take M 66 to M 21 and turn right (west).

FACILITIES: 32 paved and covered firing points. Electronically controlled sustained-fire targets.

ENTRIES LIMITED TO 32 COMPETITORS: Shoot-the-works (NRA 2700) entries given preference. Advance entries preferred so squadding can be completed. Post entries accepted to range capacity. Please include name, address, NRA# and classification. Please advise Tom if registered and unable to attend.

TIME: Registration begins at 9AM. Match starts at 1000 both days.

FEES: Registration: \$8.

CLASSIFICATION: All competitors will be classified according to the NRA Classification System. All unclassified competitors will fire in the Master class unless they have an assigned classification.

CATEGORIES: The categories will be Civilian or Service. Service will include Regular, Reserve, National Guard and Police. With fewer than five competitors in a category, the categories will be combined within the same class. Special categories for Junior, Woman, Senior, Grand Senior and (drum roll) *Great Grand Senior***.

Rules: Current NRA and CMP Pistol Rules govern the applicable matches.

TEAMS: Two person teams only. Pick-up teams allowed. Team entries must be made prior to the start of match #2. **Team matches will be fired immediately following matches #4, #9 and #14. Fired entirely at the 25-yard line using the B16 Slow Fire target for the slow fire stage.**

NOTES: Challenge fee is \$2. Bring your stapler. Lunch available at range. Triggers may be weighed on the firing line by random selection. Jury system will be used if no referee assigned. Ammunition for all matches supplied by the competitor. Eye and ear protection required.

22 Caliber Individual Matches. Starting at 1000 September 8th.

Match #1 – 20 shots slow fire, 50 yards. Match #2 – 30 shots National Match Course. Match #3 – 20 shots timed fire, 25 yards. Match #4 – 20 shots rapid fire, 25 yards. 22 caliber team match. Match #5 – Aggregate of Matches 1 – 4. (22 caliber Championship).

Centerfire Individual Matches. Starting after lunch September 8th.

Match #6 – 20 shots, slow fire, 50 yards. Match #7 – 30 shots, National Match Course. Match #8 – 20 shots timed fire, 25 yards. Match #9 – 20 shots rapid fire, 25 yards. Centerfire team match Match #10 – Aggregate of matches 6 – 9. (Centerfire Championship).

CMP .22 Rimfire Pistol EIC Match. After Centerfire Matches September 8th.

45 Caliber Individual Matches. Starting 1000 September 9th.

Match #11 – 20 shots slow fire, 50 yards. Match #12 – 30 shots National Match Course. Match #13 – 20 shots timed fire, 25 yards. Match #14 – 20 shots rapid fire, 25 yards. 45 Caliber team match Match #15 – Aggregate of matches 11 – 14. (45 Caliber Championship)

STATE CHAMPIONSHIP: Match #16 (Aggregate of matches 5, 10 and 15.)

NRA Distinguished Revolver Match. TBA. After 45 caliber matches September 9th.

• The order of firing the DR and EIC matches will be determined on site by match officials.

CMP Service Pistol EIC Match. TBA. After 45 caliber Matches September 9th.

AWARDS: There will be a winner in each match. In each class/category with 5 - 10 competitors a first place will be awarded. Cash will be the only award available. If less than five High Masters, they will compete for match winner only.
