All matches fired on Orion Scoring System equivalent targets and scored with Orion.

**Fees:** Individual: One match \$15, Two matches: \$27, Three matches: \$40, All four matches: \$50  
Teams (four person) \$11 per match, also available on day of match

**Classification:** All competitors will be classified in accordance with NRA Rule 2.3, 2.3.1 & 2.3.2 of the NRA Smallbore Rifle Rule Book. Team classification will be in accordance with NRA definition.

**Categories:** Junior – Born in 1999, 2000 & 2001 Intermediate Junior – Born in 2002, 2003 & 2004  
Sub-Juniors – Born in 2005 or later

**Rules:** NRA rules will govern the tournament where not indicated below.  
A) ECI or OBI mandatory B) Unlimited sighters allowed during shooting period  
C) *Eye & ear protection required for competitors and spectators*
