DISTANCE FIRED: 50 feet

RIFLE: Smallbore Any Rifle **SIGHTS:** Any sight

RULES: Current NRA Smallbore Rifle Rules will govern.

TARGETS: Official 50 ft., NRA/USAS 50 target for the Orion Scoring System will be used.

CATEGORIES: Categories recognized are Collegiate and Junior (Sub Jr, Int Jr and Jr combined).

CLASSIFICATION: Each competitor will be placed in one class according to the NRA Classification System and shall be prepared to exhibit his classification card or Temporary Score Record Book. Unclassified competitors will fire in the Master Class if they do not have an assigned classification.

CHALLENGES: A challenge fee of \$3.00 will be charged for each challenge made (See Rule 16.1 for correct procedure).

INDIVIDUAL ENTRIES: Open to Adults and Juniors (NRA membership is not required). **Email or telephone Michael O'Connor at the above address to reserve a position on a relay by January 5, 2021 to avoid a post entry charge.**

ENTRIES LIMITED: Entries are limited to 12 competitors for each relay and a maximum total of 24 competitors (2 – 12 person relays) which is the capacity of the range for the time allotted. Persons making entries within the time limit which cannot be accepted will be notified and their fees will be returned.

POST ENTRIES: Post entries will be accepted to the capacity of the range provided such entries will not require extra relays. **Post entries (made after January 5, 2021) will be charged a post entry fee of \$5.00.**

SQUADDING: Will be assigned by the Statistical Office.

FIRING REGULATIONS FOR MATCHES:

1. Individual stages: Two targets for the stage (position) should be mounted simultaneously.
2. Sighting Shots: Unlimited number may be fired at any time within the allotted time.
3. Shooting time: Time allowed includes sighting shots. Time remaining from one position may not be carried over to a following position regardless of the method of changing targets.
4. Firing Order: Matches must be fired in the order identified in Match Schedule.
5. Preparation Period: A three (3) minute preparation will be given before the "Commence Firing" command for each stage of the match.

STAGE 1:	20 shots prone	1 minute per shot
STAGE 2:	20 shots standing	2 minutes per shot
STAGE 3:	20 shots kneeling	1 ½ minutes per shot

TIME OF FIRING: Firing for each relay will begin at the time and date indicated below:

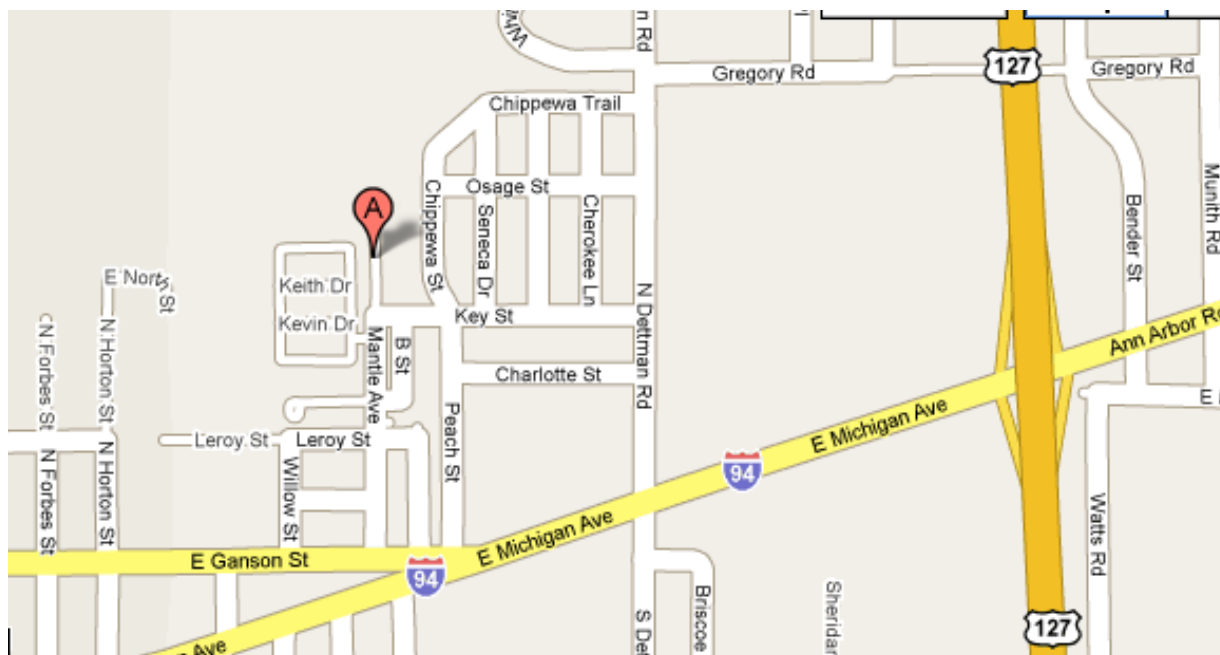
Relay 1 3-Position January 9, 2020 9:00 a.m. starting time – limited to 12 entries for this relay
 Relay 2 3-Position January 9, 2020 12:00 p.m. starting time – limited to 12 entries for this relay

AWARDS: Provided by the Michigan Rifle & Pistol Association:

Match: State Indoor 3-Position Champion – must be a MRPA member to be named State Champion
 Winner – Cash (minimum of 5 competitors)
 2nd Place – Cash (minimum of 10 competitors)
 3rd Place – Cash (minimum of 15 competitors)
 An additional place award for each 5 additional competitors

Class awards will be given in Master, Expert, Sharpshooter, and Marksman classes with a minimum of 3 competitors in a class. Classes less than 3 competitors will be combined to maximize awards however, if there are less than 3 Master Class competitors they will compete for Open category awards only (1-3 place overall).

Category awards will be given to the high category winner with a minimum of 3 competitors in a category. Categories recognized for the match awards are: Collegiate, Junior (Junior thru Sub-Junior).



Directions: Exit I-94 at US-127 S. Proceed south to the first exit (Michigan Avenue) exit at Michigan Avenue and turn right (west) on Michigan Avenue. Continue past the Meijers Store until you reach Dettman Road (approx ½ mile). Turn right (north) on Dettman Rd and in a short distance turn left on Key St. Follow Key St until it ends at Mantle Avenue. Turn right on Mantle which ends into the Club parking lot.
