

2023 MI Outdoor Precision Pistol Championship Program

Saturday and Sunday, 9 and 10 September 2023

Sponsored by Michigan Rifle and Pistol Association, Pistol Division

Hosted by the Western Michigan Rifle and Pistol Club, Ionia, MI

Matches: NRA/CMP 2700(CMP Rule 5.3.3), CMP 22 RIMFIRE EIC, CMP SERVICE PISTOL EIC AND CMP SERVICE REVOLVER EIC (40 shots). NRA DISTINGUISHED REVOLVER. Also 22caliber only aggregate if space available. Rule 5.3.3 competitors have priority.

Eligibility: Open to any individual who qualifies under NRA and CMP rules. Adult non-MRPA members will be charged a \$5 fee. To be designated "State Champion" competitor must be a Michigan resident and a member of MRPA. Competitors are required to have an "Eligibility Affidavit and Liability Agreement" on file with MRPA Pistol Division. Paperwork available at range.

Location: 2116 W. Lincoln Rd. Ionia 48846. Take the M21 west from Ionia. Turn right on Lincoln. Range is on right (north) in about 1.2 miles.

Facilities: 30 paved and covered firing points. Electronically controlled sustained-fire targets. Restrooms in clubhouse.

Bring your lunch. **Bring your lunch.** We'll have water.

2700 Match entries limited to 30 competitors. Shoot-the-works entries have preference. Advance notice of participation would be nice. Post entries accepted to range capacity.

EIC, Revolver and team match entry to be made at the range.

Registration begins at 0900. **Match starts at 1000.**

Fees: 2700: \$70. Non MRPA members add \$5.

CMP EIC Matches \$20 each. NRA Dist. Rev.: \$10. Team Package \$20.

Match Officials: Statistical Officer, Tom Lewis. Range officer and Match Director, TBD.

Classification: All competitors will be classified according to the NRA/CMP systems. Unclassified competitors will fire in the Master class unless they have an assigned classification.

Divisions: There will be Open and Metallic Divisions. With fewer than six competitors in a division, the divisions will be combined for awards. Must declare entry prior to Match #1.

Categories: The categories will be Civilian or Service. Service will include Regular, Reserve, National Guard and Police. With fewer than six competitors in a category, they will be combined within the same class. Special categories for Junior, Woman, Senior and Grand Senior.

Teams: Two-person teams only. Pick-up teams allowed. Entry must be made prior to firing Match #3. Team matches will be fired entirely on the 25 yard line immediately after Matches #4, #9 and #14 using 25-yard slow fire targets for the first stage. *Remember your lunches!*

Rules: Current NRA and CMP Pistol Rules govern the applicable matches.

Notes: Challenge fee is \$2. Bring your stapler. Triggers may be weighed on the firing line. Jury system will be used if no referee is assigned. Ammunition supplied by the competitor. Eye and ear protection and ECI use required. **Bring your lunches!**

22 Caliber Individual Matches. Starting at 1000 Saturday

- Match #1 – 20 shots slow fire, 50 yards.
- Match #2 – 30 shots National Match Course.
- Match #3 – 20 shots timed fire, 25 yards.
- Match #4 – 20 shots rapid fire, 25 yards.
- 22 caliber team match
- Match #5 – Aggregate of Matches 1 – 4. (22 caliber Championship).

Centerfire Individual Matches. Starting after a short lunch-break Saturday.

- Match #6 – 20 shots slow fire, 50 yards.
- Match #7 – 30 shots, National Match Course.
- Match #8 – 20 shots timed fire, 25 yards.
- Match #9 – 20 shots rapid fire, 25 yards.
- Centerfire team match
- Match #10 – Aggregate of Matches 6 – 9. (Centerfire Championship).

CMP 22 Rimfire Pistol EIC Match after centerfire matches Saturday.

45 Caliber Individual Matches. Starting 1000 Sunday.

- Match #11 – 20 shots slow fire, 50 yards.
- Match #12 – 30 shots National Match Course.
- Match #13 – 20 shots timed fire, 25 yards.
- Match #14 – 20 shots rapid fire, 25 yards.
- 45 Caliber Team Match.
- Match #15 - Aggregate of Matches 11 – 14. (45 Caliber Championship).

State Championship: Match #16 Aggregate of Matches 5, 10 and 15.

Remaining CMP EIC and NRA Distinguished Matches starting after a short break. Match sequence at the discretion of the Chief Range Officer.

Championship Awards: Cash. There will be a winner in each match. Competitors are eligible for only one award per match. In each class with 5 – 10 competitors first place will be awarded. If less than five High Masters, they will compete for match winner only.

Junior, Senior, Grand Senior and Woman must declare special entry before Match #1 starts. Awards (\$3) as follows: 2-3 competitors, Match #16 only. 4-5 competitors, Matches #5, #10 #15 only. Six or more competitors, Matches #5, #10, #15 and #16.

Metallic Division and 22 caliber only aggregate awards TBD.
